Why register my business with Spain Film Office?

If you provide facilities or services of interest to film production companies, you can register your services free of charge on Spain Film Office website. We have over 27 years of experience in working with international production companies. We make sure that shoots are professionally managed, financially beneficial and stress free experience for local companies.

How do I register my business with Spain Film Office?

Click on Register Your Service and complete the online form. We'll then send you further instructions. Please do not email any information, photos or videos unless we invite you to do so.

What sort of productions could my business be used for?

It could be any type of commercial shoot involving a camera – feature films, TV dramas, short films, TV shows, photoshoots, music videos or adverts. We also get enquiries for press events, product launches and other corporate events.

What kind of businesses do you represent?

Obviously we represent specialist film services like fog and snow machines, lighting, boat charters, helicopters and plain hire, pyrotechnics, catering, casting agents, etc... However there are a lot other services, which film production companies might need, such as:

Taxi, mini-bus and car hire
Construction
Electrical supplies
Paint, wallpaper, wood, haberdashery
Supplies for props and wardrobe
Armour, replica swords, trophies

Is it worth my time, would it be used?

Whilst there can be no guarantees that your registration will result in additional revenue for you, it will surely be worth spending a few minutes to register. If your business fits a film maker's brief in terms of a script/location then it will be used so long as it is able to accommodate the logistics of the shoot. As a creative Industry the boundaries have no limits.

What do Spain Film Office do for business owners?

Negotiates the fees for your services
Provides comprehensive filming & photography licenses
Ensures productions are adequately insured
Handles invoicing and fee collection
Ensures Health & Safety procedures for shoots are in place
Monitor the production during the shoot.
Cover overtime
Arrange security deposits

What is your commission?

The commission for our services is 15% of your invoice. Should there be any other costs involved these will go directly to the service supplier.

What is the procedure?

If a production is interested in your business service we will contact you to discuss the project, to check your availability and agree fees. If in turn you are interested you will be asked to sign a contact confirming all conditions and fees.
